


NATIVE AMERICAN CHILDREN, FAMILIES, AND COMMUNITIES: SOUTH DAKOTA



What Students Will Gain

- ▶ Learn to select and develop best practices (evidence based and culturally specific) when addressing the social welfare and behavioral health needs.
- ▶ Be able to engage critical thinking and cultural empathy.
- ▶ Develop the capability to effectively advocate and influence across a spectrum of social work practice.

What Students Will Gain


- ▶ Provide students a framework for understanding how policies affecting service members, veterans, and their families are developed and shaped by the government, military structure, and policy/advocacy organizations.
- ▶ Promote students' ability to use and expand evidence-based social work knowledge in professional practice to inform and evaluate policy, practice, and service-delivery systems of military social work programs and service systems for military members, veterans, their families, and/or their communities.
- ▶ Further students' knowledge and insight regarding in-garrison and deployment issues of military service as well as stressors, changes, and transitions during a veteran's life cycle through meeting with service members, veterans, and their families.
- ▶ Enable students to understand military culture and form a basis for study and action with service members, veterans, and their families.

Fred Stone joined the USC Suzanne Dworak-Peck School of Social Work in 2012. He is a colonel who served more than 27 years in the United States Air Force.

After graduating from the Virginia Military Institute, Stone was commissioned as a second lieutenant through the Air Force ROTC. From 1985 to 1990, he served as a C-130H navigator for the 772 Tactical Airlift Squadron and 463rd Tactical Airlift Wing. Stone left the Air Force to join the Texas Air National Guard while he attended The University of Texas at Arlington Graduate School of Social Work. After receiving a Master of Science in Social Work, he returned to the active duty Air Force as a clinical social worker, and in 1995 he was selected for the Air Force Institute of Technology advanced civilian degree program. In 1998, Stone earned a PhD in Social Work and a Master of Public Administration in 1998 from the University of Utah.

SOCIAL CHANGE AND INNOVATION: WASHINGTON, D.C.



What Students Will Gain

- ▶ Students will develop innovative responses to social issues, build capacity for innovation within organizations, and better understand how to build intraprofessional collaborations for social good. Between their learnings in the class and experiences in Washington, D.C., students will be better prepared to become practitioners of innovation, ready to introduce new ways of thinking about and enacting change.
- ▶ Provide students with an enhanced understanding of how Federal legislation and policies affect programs for children and families at the local level and with knowledge and opportunities to become more effective advocates in their social work practice.
- ▶ Demonstrate to students the importance (and limitations) of basic research and program evaluation evidence in the development of social policies and the critical value of such evidence in social policy briefs and other written documents.



Program Costs

- ▶ Tuition:
 - ▶ \$1,863 x 3 Units=
\$5,589 plus Academic Fees
- ▶ Program Fee:
 - ▶ DC Immersions: \$1,550 plus **Transportation**
 - ▶ South Dakota: \$1,450 plus **Transportation**
- ▶ Estimate Round Trip Transportation (from LAX):
 - ▶ Washington DC: **\$400-\$600**
 - ▶ South Dakota: **\$500-700**

Program Fee includes: Lodging (double room occupancy, breakfast included), local transportation, weekday lunches, cultural activities, tours, and field visits.

Other Fees include: Required health insurance if not enrolled in mandatory USC health insurance plan. Participants are also responsible for their own dinners, weekend lunches, snacks, non-program local transportation and other incidentals.

Additional Information

▶ Application Process

- ▶ Application and \$250.00 non-refundable deposit are due by **Friday, October 5, 2018**. (Checks or money orders made out to the **University of Southern California**)
- ▶ In order to apply, you must have a minimum 3.0 GPA and have completed all foundation requirements. The sooner you apply, the better chance you will have in being accepted into the program of your choice.
- ▶ Program fee balance is due no later than **Friday, January 18, 2019**.

Note: You must be enrolled in 3-unit elective social work course in order to participate on a national immersion program.

▶ Financial Aid

- ▶ If you are receiving financial aid, you may also be able to use it toward your immersion study. See the School's Office of Scholarship Programs.
