In response to health care challenges that the conflicts in Iraq and Afghanistan have placed on the population of service members and their families, the U.S. Defense Centers of Excellence for Psychological Health and Traumatic Brain Injury (DCoE) have funded development of an intelligent, interactive, online virtual human healthcare guide program currently referred to as SimCoach. The SimCoach project is developing virtual human support agents to serve as online guides for assisting military personnel and family members in

The \$7.6M DoDEA initiative is a partnership between eight military-connected districts and the University of Southern California (USC). Support to military students and their families includes 72,000 contact hours from a cadre of 30 Master of Social Work interns and their mentors. This grant focuses on helping schools and districts nationwide transform into trauma-informed school communities that help prevent traumatic stress and promote recovery and wellness for trauma-exposed students. Building on our USC/RAND partnership, a 19-year collaboration and extensive experience creating and disseminating tools and interventions to help schools nationwide better meet the needs of ethnically/racially diverse trauma-exposed students and prevent deleterious sequelae of trauma, we will continue and expand our work within the National Child Traumatic Stress Network (NCTSN) and across our nation's schools by working at three levels: 1) the student and family level by supporting widespread implementation of school prevention and early trauma interventions with school mental health professionals (school social works and psychologists), leveraging reach and efficiency through the use of technology and implementation science; 2) the educator level by extending trauma-informed skills to teachers; and 3) the school community level by supporting schools and districts, including all faculty, staff, students and parents, in identifying areas of strengths and weakness and using that information to develop and implement a school specific trauma-informed school practices that best meet the identified needs.

This approach is informed by almost two decades of work with schools, understanding that promoting recovery and wellness in trauma-exposed students requires not only using effective interventions, but also developing a school environment and personnel that can support students and the successful implementation of interventions. From extensive collaborations with schools across the country, we have learned that readiness to adopt trauma-informed practices varies considerably. The TSA for Schools "meets schools where they are" to help them improve their trauma-informed approach.
