Biographical Statement:

Graham DiGuiseppi's research focuses on the intersecting populations of youth experiencing homelessness and youth at risk of developing substance use disorders. Graham's dissertation research is funded by the National Institute on Drug Abuse, and focuses on the antecedents and consequences of homelessness among young adults receiving substance use treatment. Specifically, Graham uses advanced quantitative methods (machine learning, structural equation modeling) and mixed methods (in-depth interviews with young adults and their providers) to understand risk and protective factors for homelessness, bidirectional relationships between homelessness experiences and treatment outcomes, and facilitators and barriers to treatment engagement.

Graham is looking forward to continuing his research with vulnerable adolescent and young adult populations, and training future generations of social work researchers and professionals. Specifically, Graham's aims for his future research and advocacy work to focus on providing evidence-based services to youth with (or at risk of) developing substance use disorders, and using innovative mixed methods to understand the etiology and improve treatment for substance use disorders. Ultimately, Graham hopes that this work will increase access to effective services that harness youths' strengths and healthy development. 

Biographical Statement:

Woo Jung (Amy) Lee's research focuses on risk and protective factors embedded at the individual and contextual levels that contribute to adolescent mental health from a life course perspective. Her research agenda includes understanding the impact of poverty, racial discrimination, and the influence of cultural context on mental health among low income and ethnic minority/immigrant youth, with a particular interest in Asian American experiences. Leveraging her interdisciplinary background in psychology and social work, she focuses on how psychobiological risk processes embedded at the individual level, including socioemotional and cognitive development, and those embedded at higher contextual levels, such as family and neighborhood factors, intersect with each other to contribute to socioeconomic and racial disparities in youth mental and behavioral health. For the qualifying exam, Amy investigated the role of cumulative risk on the link between automatic emotion regulation and mental health among Asian American adolescents. Her doctoral dissertation uses a mixed methods approach to extend the research on how neighborhood disadvantage is associated with adolescent mental health trajectories and the mechanisms that underlie this process using the Adolescent Brain and Cognitive Development study (N = 11,876), a prospective nation-wide multi-site study on biological, social, and environmental factors that influence adolescent development. She also employs a qualitative approach that considers the unique contexts of pan-ethnic Asian identity, cultural history, neighborhood factors, and COVID-19-related discrimination experiences and how they intersect with each other to influence mental health among Asian American youth. Amy has demonstrated strong quantitative skills using advanced modeling strategies, and her work has culminated in authored or co-authored manuscripts in key multidisciplinary journals and presentation of the work at national conferences. In addition to scholarly interests, Amy has an extensive teaching experience at the bachelor's, master's, and PhD level in research methods and statistics courses in the departments of social work and psychology and has expertise teaching both in person and online. Leslie has taken on leadership roles in her research activities, including serving as a project manager for an interdisciplinary study with an international team aimed at building a community health-safety climate measure. Through this study, Leslie contributed to the development of a validated climate measure utilizing a national sample and coordinated the submission of a National Science Foundation (NSF) grant. Leslie has strengths in mixed-method approaches, scale development, as well as qualitative data collection and analysis. Through her organizational and community-based research experiences, Leslie has honed skills with project management, research design and planning, and relationship building with collaborative partners.

Biographical Statement:

Sara Semborski is passionate about translating research into advocacy and action to improve outcomes for at-risk youth and young adults. Prior to pursuing her doctorate, Sara obtained her clinical license in social work through direct service with both adults and young adults experiencing homelessness. Sara's clinical and research experience focused on understanding the socio-environmental contexts associated with the experience of homelessness to promote age-appropriate, evidence-based interventions. Her dissertation, funded by a two-year Ruth L. Kirschstein National Research Service Award from the National Institute of Mental Health, utilizes geographic Ecological Momentary Assessment (EMA), an innovative, momentary sampling method complete with location data to examine the social and physical contexts associated with mood and emotional regulation among young adults who have experienced homelessness. To fulfill her aims, Sara is using an array of methods including advanced quantitative methods to model intensive longitudinal data, social network analysis, and spatial analysis. Her work with intensive longitudinal data also produced a first-authored paper on the feasibility of EMA with young people experiencing homelessness. Among Sara's strengths is her integrative approach, uniting research and practice.

As a social worker rooted in social justice, Sara emphasizes examining problems holistically, encompassing both individuals and the many systems in which they are embedded. To achieve this, Sara has been trained in mixed methods, leading both qualitative and advanced quantitative analyses to publication. To date, Sara has 11 first-authored papers. Her first-authored work has been published in journals like *JMIR Formative Research* (IF=7.08) and Psychological Assessment (IF=6.08). Since arriving at USC, Sara has participated in NIH-funded studies from start to completion, engaging in all aspects of the research process including study design, data collection where she was involved in both quantitative and qualitative arms, analysis, and dissemination. Additionally, Sara has instructed and co-instructed a diversity of courses, at both the Master's and PhD level, ranging from clinical courses to research methods and advanced statistics. Overall, Sara is energized by the dynamic work she is engaged in and seeks to bring that energy to a collaborative environment that is committed to forward progress for everyone, particularly those most excluded.
