Adriane Clomax investigates minority workers' intersectional experience in various workplaces, including the US Army and worker-owned businesses. Her research interests include fair working conditions, workplace democracy, and inclusive leadership practices. Before matriculating at USC, Adriane worked domestically and internationally on employment and economic well-being issues. She realized poverty, family well-being, and community safety could be tied back to the availability of quality employment. As a student, Adriane has participated in two major research projects that have examined workplace inclusion policies in the US Army and worker outcomes in employee-owned businesses. Through these two projects, Adriane honed her qualitative and quantitative research skills.

As a USC Suzanne Dworak-Peck School of Social Work community member, Adriane served on the Doctoral Student Association. In this role, she worked with USC faculty to create avenues for Ph.D. students and candidates to share their work through the annual student research symposium. She also worked with the social justice curriculum committee to create the "Social Justice Bootcamp" for incoming Ph.D. students.

Adriane has led projects with the King's College of London, contributing to papers focused on the occupational experiences of Black workers, particularly women. She also completed a fellowship with the Institute for the Cooperative Digital Economy at the New School in New York City, where she helped develop a worker-owner-centered policy report for platform cooperatives, emphasizing diversity and inclusion. She has also been a fellow with the Institute for the Study of Employee Ownership and Profit Sharing at Rutgers University. Adriane worked on her dissertation as a fellow, which concerns Black workers, employee ownership, and fair wages.



Biographical Statement:

Jiaming Liang is a gerontological social work researcher whose primary focus is on enhancing the physical and mental health, as well as the overall quality of life, of older adults and their families from various racial/ethnic and cultural backgrounds. Specifically, Jiaming uses quantitative and qualitative methods to examine complex phenomena such as social support, loneliness, chronic conditions, sleep quality, depression, and cognitive functioning among older adult-caregiver dyads, with the aim of identifying and implementing effective and sustainable interventions to benefit the community.

Jiaming's current and future research agenda includes pursuing multiple funding opportunities to support the development and evaluation of evidence-based, community-centered programs targeting the health and well-being of older adults with long-term care needs and their family caregivers in diverse communities. Specifically, Jiaming plans to explore the social, behavioral, and physiological mechanisms that affect cognitive health and quality of life among diverse older adults and their family members. Such work will support the development of community-based programs that empower older adult-family caregiver dyads to effectively manage cognitive health and enhance quality of life.

In addition to his research interests, Jiaming has extensive experience teaching both in-person and online courses in social and behavioral theories, research methods, program development and evaluation, and statistics at the undergraduate and graduate (master's and PhD) levels. 

Biographical Statement:

Rory O'Brien studies the adoption and implementation of social policy to address disparities among marginalized adolescents and transition age youth. They use a wide variety of quantitative and qualitative tools to investigate the youth's lived experiences of social policy, facilitators and barriers to local enactment of policies, and civic youth development and leadership. Ultimately, Rory's research goals are to produce evidence to support effective local implementation of policies to respect, protect, and fulfill the rights of marginalized youth, inform policymaker decision-making on marginalized youth rights, and meaningfully engage youth communities in the research and policies that shape their daily experiences.


Prior to their PhD in Social Work, Rory worked at local, state, and national levels on youth policy for human trafficking and public mental health systems. In this work, they researched how policies serve youth, including listening sessions with providers nationwide on the tailoring of anti-trafficking services to marginalized youth, town halls with mental health consumers to identify California statewide policy priorities, and interviews with county staff on barriers to collecting SOGI data. This research highlighted how localities vary in adoption, reinterpretation, and implementation of state and national policies, and inspired Rory to pursue further training in research to understand local enactment of youth policy.

Their PhD-level research has investigated the effects of state- and county-level structural stigma on sexual minority youth mental health; measurement issues in sexual orientation and gender identity (SOGI) data collection in public health surveillance; and the experiences of multiply marginalized LGBTQ youth of color, rural youth, and impoverished youth. Rory's dissertation involved case studies of 10 public school in Los Angeles to examine adoption and implementation of LGBTQ-supportive school policies, facilitators and barriers to student activism in schools, and change in school policies and facilities over time. This effort included distribution of findings to student activists in schools, who planned and implemented their own activist interventions to change school policies. While managing a multi-site multi-year dissertation project, Rory has continued publishing with research labs USC and Washington University in St Louis and has successfully attracted multiple intramural grants and fellowships.

Rory is an experienced educator who has taught and mentored at the undergraduate and graduate with multiple academies. With the American University Women's and Gender Studies department, Rory taught their introductory course and, upon strong reviews of their teaching, was quickly entrusted by the department chair to design novel courses in Transgender Studies and Anti-Violence Interventions. Years later at the University of Southern California, Rory served in the virtual academic center first as a teacher assistant and then co-teacher for a course on youth policy analysis and practice, Macro Practice with Children, Youth, & Families. Rory also attended the Future Faculty Institute with USC's Center for Excellence in Teaching, where they gained skills in backward curriculum design, developing rubrics, academic dishonesty, and implications of artificial intelligence to modern education.

Rory looks forward to building upon this research agenda as future faculty. They plan to further inquire into school policy implementation with a larger sample of schools and to pursue an investigation of foster parent cultural competency training policy implementation by foster family agencies in California.

Biographical Statement:

Shaddy Saba has had a decade-long career in behavioral health research and clinical practice, focusing on the intersection between behavioral health and physical pain among underserved populations (i.e., military veterans, young people who have experienced trauma). For his NIH-funded dissertation research, he utilizes intensive longitudinal modeling, machine learning, and qualitative interviews to study the dynamic interplay between pain and PTSD symptoms among veterans recently returning from deployment. His research moves the needle to a better understanding of how multi-morbid conditions develop and impact one another, with the goal of providing more targeted and effective intervention and prevention strategies for underserved populations. Shaddy's work has been funded by the National Institute on Drug Abuse, the Department of Veterans Affairs, and the USC Center for Mindfulness Science. He has authored or co-authored over 30 published manuscripts in reputable journals on topics including the health effects of traumatic experiences, associations between pain and PTSD symptomology, integrated healthcare models, and mindfulness-based interventions.

Shaddy has worked to develop a broad methodological toolkit so he can effectively study predictors and consequences of complex, multi-morbid behavioral health symptomology. He is particularly experienced in longitudinal data analysis using structural equation modeling. Given the proliferation of rich, novel data sources (e.g., data from wearable devices, large publicly available social datasets) he has also developed skill in data science approaches (i.e., machine learning). His work is grounded in relevant theory on multi-morbidity (i.e., models of mutual maintenance and shared vulnerability), with the goal of advancing both theoretical and empirical knowledge. To that end, he increasingly integrates psychophysiological (e.g., heart rate variability), structural (e.g., area-level disadvantage), and sociocultural (e.g., identity and discrimination) determinants of behavioral health into his work.

Shaddy is a licensed clinical social worker, and his research is informed by several years' clinical practice experience in mental health, substance use, and chronic pain treatment settings. He is excited to mentor the next generation of social work scientists and practitioners, and he has experience teaching both masters- and doctoral-level coursework. He is well-prepared to teach courses on introductory and advanced clinical practice, research and evaluation, statistics and data analysis, and theories of human behavior in the social environment.
