Lead the adoption of a community-based violence intervention program for USC. (2021-present)

The objective is for USC Department of Public Safety, in collaboration with the Suzanne Dworak-Peck School of Social Work, to adopt evolving protocols and establish a triage call center to address non-violent, community related issues.

Lead the USC Community-Based Youth Violence Prevention Project: A UPC neighborhood youth diversion pilot program (2022-present)

A youth diversion pilot program has been launched in University Gardens near the University Park Campus. The project is a collaboration between the USC Suzanne Dworak-Peck School of Social Work, non-profit Inner-City Visions (ICV) and in partnership with USC's Department of Public Safety and local mental health organization Wellnest. This program takes a multi-pronged approach to provide services to the most vulnerable and marginalized youth in the neighborhood. Inner City Vision's community-based violence reduction specialists will be able to divert and direct youth in South Central Los Angeles to increased opportunities and engagement while assisting USC in implementing its ONE USC Safety Vision of community safety for students, staff, faculty, and the neighborhood. Services that will be administered include, but are not limited to job and career readiness, counseling, trauma informed care, afterschool programming, tutoring and mentorship.

Serving as a team member to evaluate the City of Los Angeles' 911 call diversion initiative. (2021- present)

The project aims to evaluate the effectiveness of a mental-health 911 call diversion initiative (titled "Call Direction to Ensure Suicide Safety") comprehensively. In collaboration with Didi Hirsch and LAPD. The program is designed to divert 9-1-1 calls to the Didi Hirsch Suicide Prevention Center rather than to law enforcement for persons in a mental health crisis. Working alongside a team of researchers from the USC Suzanne Dworak Peck School of Social Work our role is to broaden evaluation outcomes in collaboration with Didi Hirsch, Los Angeles Police Department, the LA mayor's office, and the LA city council. We aim to generate a rigorous report that can inform relevant criminal justice policies locally and nationally.

Co-Lead Organizer of the "Community Safety" Conference.

The 2024, Tri-County Collaborative which consist of Los Angeles, Orange, and San Diego, counties hosted the "Community Safety" conference in partnership with USC's Public Safety

Department, USC's Human Relations Department, and the USC Suzanne Dworak-Peck, School of Social Work with support from SC-CSTI: Southern California Clinical and Translational Science Institute. This year's conference was held on the East side of town at USC's Health Science campus. The Tri-County Collaborative CSC hosted over 200 CBO's and their respective community members and leadership personnel. In commemorating the conference's inaugural decade in 2024, The Tri-County Collaborative- CSC reflected on the invaluable wisdom of their respective community elders, who possess valuable insights into community building and creating a safer environment for all. For this ten-year milestone, the conference actively endeavored to pass on wisdom to the younger generation. By examining the current community safety landscape and envisioning a future that amplifies the community's voice, the Tri-County Collaborative's overall arching goal is to empower and propel the collective voice of the community for years to come to make communities better and safer.

Served on President Folt's Department of Public Safety Implementation Committee for the University of Southern California. (2021 – 2023)

Worked with implementation committee composed of academics, and staff, to ensure the recommendations by the Community Advisory Board report to re-think public safety at USC is fully implemented.

Co-Lead Organizer of the "Community Safety" Conference. (2023) The 2023, Tri-County Collaborative "Community Safety" conference in partnership with USC's Public Safety Department, USC's Human Relations Department, and the USC Suzanne Dworak-Peck, School of Social Work hosted close to 400 community members at the USC's Galen Founders Room. Community Immersion – USC Suzanne Dworak Peck School of Social Work (2008-2018) Since 2008, I have been a course instructor assisting with the facilitation and implementation of community immersion for our newly admitted MSW graduate students on the ground and virtually as part of their orientation into the school. The week-long program consists of writing workshops and an in the community experience which segues into students first semester policy courses. Students are introduced to concepts related to community, and diversity, and challenges individuals and families interact with daily and the role social workers play within this process to better serve their constituents.

Hosted the Annual Youth Justice Coalition – FREE LA HIGH GRADUTION (2018) Annually the Department of Education in collaboration with Los Angeles County Department of Education and Community Based Organization - Youth Justice Coalition, celebrate the successful completion of high school for justice involved youth within the County of Los Angeles.
