Grant Activity

Co-Investigator: Support for Trauma Affected Refugees (STAR), Department of Health and Human Services, Administration for Children and Families, Office of Refugee Resettlement.

Awarded \$496,700 per year for four years to provide holistic trauma assistance and mental health services to trauma-affected refugees in the greater Los Angeles (LA) area to help them achieve self-sufficiency, recovery, and wellness. (Initial funding for Sept 24 to Sept 25, with additional funding to be determined under the new administration).
